1. INTRODUCTION

Dinabandhu Sahu Law College, Kendrapara, established in the year 1986, is situated on the left side of the State Highway leading from Cuttack to Kendrapara at a distance of about 1 Kilometer from Duhuria. The College imparts education in three years Bachelor Degree Course in Law under Choice Based Credit System.

2. RE- OPENING AND COMMENCEMENT OF CLASSES

The College reopens on 18th June 2025 after Summer Vacation.

3. GENERAL RULES FOR ADMISSION

(A) Application for Admission

Applicant who seeks admission in to 1st Year LL.B Course shall obtain the prescribed application form within 15 days from the date of publication of +3 Degree results. The prescribed application form and prospectus will be available in the college office during office hours in all working days on payment of Rs. 600/- . The application form and admission brochure can also be downloaded from the college website and the duly filled in application form along with application fee receipt and other requisite documents shall be submitted in the college in a sealed envelope.

(B) Submission of Application

The application form and information sheet should be filled in by the applicant's own handwriting. Entries in all columns should be filled in properly with suitable answers and not by dots and dashes or cross marks. NA should be written whenever anything is not applicable. Application form complete in all respects may be either sent by post to the **Principal, D.S. Law College, P.o.- Thakurpatna, Dist- Kendrapara- 754250**, so as to be received in the college ...

office on or before the last date specified or dropped in the box kept in the college office after being sealed in a cover.

(C) Documents to be submitted

Application form must be duly filled in only by the applicant.

After filling with the required particulars the application form is to be submitted along with the following documents.

- (i) Original money receipt of the application form
- (ii) One recent passport size attested colour photograph of the applicant to be pasted in the form at specified space
- (iii) Self attested xerox copy of the Marksheet of the qualifying examination and Certificate from H.S.C onwards
- (iv) Self attested xerox copy of College Leaving Certificate and Conduct Certificate from the Head of the Institution last attended
- (v) Recent attested xerox copy of Caste Certificate (in case of SC/ST/OBC/SEBC)
- (vi) Attested xerox copy of other Certificates claiming weightage for admission
- (vii) Attested xerox copy of Aadhaar Card

(D) Eligibility Requirements

An applicant who has successfully completed +3 Examination in any stream or equivalent course from a recognized University of India or from any Institution constituted or recognized by the Union or by the State Government, shall be eligible for admission into 3 year LL.B. Degree Course.

The Candidate belonging to the general (unreserved) category shall have to secure at least 45% of the total marks in aggregate and the candidate belonging to SC/ST category shall have to secure at least 40% of the total marks in aggregate for admission to the course. There shall be no relaxation of minimum marks to be eligible for admission.

As per Bar Council of India the declaration prescribed in the admission form is mandatory

(E) Reservation of Seats

The seats are reserved for candidates belonging to Scheduled Caste and Scheduled Tribe as per Govt. Rules.

(F) Weightage

Weightage and special consideration will be given in the following cases :

Sports – The following categories of sports persons will be given admission/ weightage under the sports category subject to selection of a maximum of 2% of total numbers of seats.

- (i) Representing the country at International Level - Direct admission
- (ii) Representing the State at National Level - 10% additional mark over the aggregate
- (iii) Representing the University at Inter-University Level - 5% additional mark over the aggregate

The above mentioned sports must be recognized or organized by the Director of Sports or University Sports Council. In order to get the weightage in sports, the concerned applicant must have participated in the respective competitions within three years before the date of application for admission.

N.B. –

The above rules regarding reservations and weightage are however subject to rules framed by the Government of Odisha in this regard from time to time. The merit list drawn by the Institution shall be final for all purposes.

(G) Selection Procedure for Admission

- (i) Admission to the college can not be claimed as a matter of right and may be refused without assigning any reason thereof. Conduct of the candidate shall be an important factor in deciding his/her admission.
- (ii) Selected candidates seeking admission will be informed of their selection in order of merit with dispatch of the intimation letter by post / email / WhatsApp.
- (iii) Certificates submitted in support of reservation and weightage will be sent to appropriate authority for scrutiny, if necessary.
- (iv) Suppression of facts or submission of incorrect / incomplete information by the applicant, if detected at the time of admission or thereafter will render the selection/ admission invalid and matter will be reported to appropriate authority to initiate criminal proceeding.

4. COURSE STRUCTURE

- (i) The 3 years LL.B degree course has been designed in accordance with the standard and regulations prescribed by the UGC, the Bar Council of India Rules on Legal Education (2008) and Madhusudan Law University from time to time.
- (ii) The three years LL.B Degree Course shall comprise 30 papers with 5 papers in each semester carrying 100 marks

(iii) Each paper consists of credits. The total credit for the course shall be of 30 multiplied by 4 equal to 120 credits.

(iv) Detailed Syllabus, ID Card and Library Card will be provided within 15 days from the date of admission.

ATTENDANCE

No candidate shall be allowed to take the semester examination in a subject if she/ he has not attended at least 75% of classes in all the subjects taken together for each semester, including the moot court exercise, tutorials and practical training.

A candidate who represents on Institution of State / National / International level in any Co-curricular or Extra Curricular activities with the prior permission of Vice Chancellor, his/her absence in the class, may be considered as present for the period attended or participated.

SYSTEM OF EXAMINATION

Each course paper shall be of 100 marks. For evaluation, the overall structure of the distribution of marks in end semester examination shall be such that 30 marks shall be allotted to Internal Assessments during the semester, while 70 marks shall be allotted for the End Semester Examinations. For Theory and Practical, the examination system shall be different and is as per details given below.

Internal Assessment

(i) The breakup of 30 marks for the Internal Assessment is given below:

Mid –Semester Test ----- 15 marks

Written Assignment /

Moot Court Exercise ----- 10 marks (5 marks for Written Assignment & 5 marks for oral presentation)

Attendance ----- 5 marks

- I. The mid-semester examination shall consist of two questions from first two Units and the student is required to answer one question carrying 15 marks.
- II. In case an student fails to appear examination in any one or more subjects or has failed to secure the minimum pass marks in one or more papers or in aggregate, her/his internal assessment marks shall be carried forward to the subsequent examination.
- III. In case any student fails to secure 50 percent marks in the internal assessment, he / she shall appear in the next respective semester (i.e. first, third, fifth semester and second, fourth, sixth semester)

A. End Semester Examination and Evaluation for 70 marks

- I. The Controller of Examinations, Madhusudan Law University shall notify the examination schedule on completion of course.
- II. The question paper will have nine questions. Question 1 is compulsory and shall have four short questions from all the four units and each question carries 3.5 marks. The paper setter is required to set eight questions with two questions from each Unit i.e Unit I to Unit IV. The candidate shall have to attempt four questions, selecting one question from each Unit. Each question carries 14 marks.

B. Practical Courses

- i. For the practical courses, i.e., Alternative Dispute Resolution, Professional Ethics, Drafting, Pleading and Conveyancing the distribution of marks for the examination shall be as follows :

End Semester ---- 48 marks

Mid- Semester ---- 7 marks

Attendance ----- 5 marks

**Practical ----- 40 marks (20 marks for written assignment
and 20 marks for Viva-Voce)**

- ii. Both the assignment and Viva-Voce shall be evaluated by the committee constituted by the Vice- Chancellor.
- iii. Moot Court Exercise and Internship: This paper shall have three components of 30 marks each and Viva for 10 marks.
- iv. Moot Court (30 marks). Every Candidate shall be required to do at least three moot court exercises in the semester with 10 marks for each. The moot court work will be evaluated for 5 marks for written submissions and 5 marks for oral advocacy.
- (v) Observance of Trial in two cases, one Civil and one Criminal (30 marks): Candidates shall be required to attend two trials during sixth semester of the course. They shall maintain a proper record and enter the various steps observed during their attendance on different days in the court in a practical file. This scheme will carry 30 Marks.
- (vi) Interviewing techniques, pretrial preparations and Internship diary (30 marks): Each student shall observe two interviewing sessions of clients at the Lawyer's Office/ Chamber and record the proceedings in a diary and relevant forms, which will carry 15 Marks. Each student will further observe the preparation of documents and court- papers by the Advocate and the procedure for the filing of the suit / petition. This will be recorded in the diary, which will carry 15 marks.
- (vii) The proof to the effect that this paper will be Viva-Voce examination on all the above three aspects. This will carry 10 marks.
- (viii) This paper shall be evaluated by a Committee constituted by the Vice-Chancellor.

5. READMISSION

An eligible student is required to take readmission on deposit of fees in each year. A student admitted in to 3 Years LL.B course is required to take readmission into 2nd & 3rd year course only when he / she becomes eligible. Normally the readmission takes place in the months of June and July. Students must follow the notice being issued by the college authority relating to dates and fees of readmission and act accordingly or else his / her studentship may be ceased.

6. AWARD OF DEGREE

On successful completion of the Course and examinations (all the semesters) the students will be awarded the LL.B. degree by the Madhusudan Law University.

7. CAMPUS DISCIPLINE

A student of this College (Dinabandhu Sahu Law College) must behave and conduct himself / herself in a disciplined manner both inside and outside the College premises. He/ She must abide by all the rules and regulations prescribed from time to time by the College Authorities and shall not conduct himself/ herself in any manner prejudicial to the honour and dignity of the Institution. The campus of the College is strictly a no-smoking and non-alcoholic zone. Any deviation from this will be seriously viewed which shall attract strong action by the Authorities. Ragging and Sexual harassment are also strictly prohibited in the campus. Strong disciplinary proceeding shall be initiated against the student violating these restrictions, which may result in severe punishment including suspension and expulsion of the student from the Institution. The decision of the Principal with regard to the matters not covered in this Prospectus or with regard to any dispute arising out of the interpretation of any clause/ clauses of the Prospectus, shall be final and binding.
